

## MEMORANDUM OF UNDERSTANDING

Between

**Engineering Council of India (ECI)**

having its registered office at **1304 Hemkunt Chambers, 89 Nehru Place, New Delhi-110019** herein after called the **"First Party"** (which expression shall, unless repugnant to the context, includes its authorized Member Associations, its successors and assignees of the First Party).

**AND**

**Vishwavidyalaya Engineering College (VEC), Ambikapur**

(A Constituent College of Chhattisgarh Swami Vivekanand Technical University, Bhilai)

having its registered office at Ambikapur, Chhattisgarh, India and hereinafter called the **"Second Party"** (which expression shall, unless repugnant to the context, include its successors, and assignees of the **"Second Party"**).

WHEREAS, ECI is registered as a Not-for-profit Society under the Societies Registration Act, 1860 and is the Apex body of the engineering profession in India. It is mandated to work for the advancement of engineering profession in various disciplines and for enhancing the image of engineers in society, by focusing on quality and accountability of engineers. Among its founding members are Planning Commission (Now NITI Aayog), All India Council for Technical Education (AICTE), National Board of Accreditation (NBA), Central Public Works Department (Ministry of Urban Development), Department of Commerce (Ministry of Commerce & Industry), Dept. of Secondary and Higher Education (Ministry of HRD), Department of Scientific and Industrial Research, Council of Scientific & Industrial Research & several other Professional Institutions.

WHEREAS Vishwavidyalaya Engineering College (VEC), Ambikapur is an affiliating college located in Ambikapur in the state of Chhattisgarh, India. All India Council of Technical Education (AICTE), a statutory body through an Act of Parliament 52, in 1987, for regulating and controlling Technical Education in India, has made ECI the authorized body to facilitate Hands-on training and/or arrange for "internships" to technical stream students in all disciplines of engineering and management in AICTE approved technical educational institutions for their Continuing Professional Development (CPD).

WHEREAS, the First Party has launched a scheme for industrial training students of all streams of engineering education at degree and diploma levels for engineering and graduation and post-graduation levels for management. These programs would be controlled and modulated by ECI or through its Member Associations (MA).

AND WHEREAS, the Second Party is desirous of tying up with the First Party under the said AICTE-ECI scheme for Training, and agrees to for carrying out the above mentioned training for its as well as its affiliated colleges/ institutions' students in its own or its affiliated colleges/ institutions' premises with its own resources / or arrange through appropriate industry relevant to the requirement of the concerned student.

NOW, THE FIRST AND SECOND PARTIES here in and here by agree to collaborate for the purpose of initiating, developing and implementing programmes of training of Engineering and Management students at degree/ diploma level for engineering and/ or graduate and Post



graduate levels for management students with the Second Party, agreeing to utilize its resources for conducting such training as well as assist the second Party to develop its other facilities.

## **RESPONSIBILITIES:**

### **A. FIRST PARTY:**

The First Party (subject to payment of relevant fees & dues by Second Party (by itself or its affiliated colleges/ institutions or their students) to First Party and / or its authorized Member Associations) shall coordinate and modulate the industrial internship of the students of the second party or its affiliated colleges/ institutions, as well as its other initiatives, for a period of 5 years initially, extendable to such periods as are approved by the first party from time to time.

The First Party is responsible for providing the syllabi, curricula of the programs to be offered by the Second Party.

The Second Party will not add to, subtract from or substitute all or any of the above at a future date or alter the duration of training and/ or number of trainees in its training courses without the approval of the First Party. In all matters concerning training, testing and certification under this scheme, the First Party shall provide the systems and procedures.

The first Party shall conduct examinations or jury interviews, of candidates trained under the approved programs and issue certificates to the successful ones. The Second Party shall ensure that due cognition is given to this process, by not permitting award of degree until this stage is cleared. Its authorized Member Associations shall discharge the obligations of the first party.

The first Party shall also provide to the second Party :-

1. With an aim to encourage continuous and sustained skill and knowledge up gradation of the teaching staff and the students, the National Register of Professional Engineers have been put in place. The first Party will register all the second Party's students and Engineering faculty members in its National Register of Professional Engineers, on payment of relevant fees and submission of relevant documentations.
2. Skilling of faculty members to be able to mentor and guide the students undertaking internships, as per the guidelines of ECI.
3. Assistance in making available programs for upgrading the skills and knowledge of the teaching faculty as well utilization of talented faculty for such programs for other colleges / students or working professionals.

4. Assistance in arranging lectures from industry experts both from India as well as abroad.
5. Assistance in arranging R & D Projects, to be taken up with the industry, under the supervision and guidance of ECI.
6. Assistance in arranging Consultancy works, to be obtained and taken up, under the supervision and guidance of ECI.
7. Assistance in upgradation of the facilities and curricula of the college.
8. Assistance in site / industry visits.

#### **B. SECOND PARTY**

The second Party will also open a Students' Chapter of the first Party. The basic requirements of the Students' Chapter are:

1. Minimum two registered Professional Engineers from the faculty. They will work as Mentors to the students & Coordinators with the first Party.
2. Minimum continuous 50 registered students
3. Five representatives from these students to coordinate with mentors and the first Party.
4. Following the rules, regulations, code of ethics and other provisions laid down by the first Party.

The Second Party shall ensure that all training is conducted in conformity with the standards, norms, methods approved under the First Party or its Member Associations scheme for training and education. The Second Party shall also ensure that all training is conducted only as per courses approved by the First Party.

The Second Party/their affiliated Institutions shall ensure that the fees are paid to the First Party and /or their authorized Member Associations as prescribed by the First Party from time to time.

The Second Party shall ensure the provision of minimum number of trainees, resources of space, manpower, equipment, material and other facilities as directed by the First Party. In this connection, the Second Party will furnish relevant information as required by the First Party and facilitate initial and subsequent inspection of their facilities.

#### **TERMINATION**

This MoU could be terminated by giving a notice of one year or the conclusion of ongoing programs, whichever is later, from side, however the first right of refusal / acceptance shall be that of the first party.
