

Details of apprentices at Moher & Moher Amlori Extension OCP, Sasan Power Limited
for the FY 2022-23

Sasan Power Limited (SPL), a wholly owned subsidiary of Reliance Power Limited, is operating a 3960MW Coal-based Thermal Power Plant at Sasan, Tehsil and District Singrauli, Madhya Pradesh. SPL have been allotted the captive coal blocks of Moher & Moher-Amlori Extension, with a peak production capacity of 20 MTPA, to fulfill the fuel requirement of the power plant. Power generated from Power Plant is sold to 14 procurers, ultimately benefitting 42 crore citizens who are spread across 7 states. With the help of the coal block, Sasan Power Plant currently produces cheapest electricity in India. The mine is located in the South-Western part of Moher sub-basin, in Singrauli Coalfield area, Dist. Singrauli, M.P. The mine has all the statutory permits in place for the Annual coal production capacity of 20 MTe. The mining methodology used for the production is Shovel Dumper and Dragline combination for the Over Burden removal and FL and Dumper Combination for the extraction of coal. The mine has largest fleet of biggest size equipment fleet in the country.

2. Eligibility Criteria:

- a. Education qualification and age as defined in syllabus under the apprenticeship act.
 - b. The applicants should NOT have completed three years after passing of the qualifying examination as on 01.08.2022, i.e, candidates having passed the Graduation/diploma/ITI in the year 2022, 2021 and 2020 are only eligible to apply.
 - c. Minimum 60% marks in ITI/ Diploma/ Graduation.
 - d. **Candidates who have previously undergone Apprenticeship Training or are presently undergoing Apprenticeship Training or presently in employment elsewhere or registered for apprenticeship Training under the Apprenticeship Act elsewhere are not eligible to apply**
3. **PERIOD OF APPRENTICESHIP TRAINING:** 12 months from commencing of the Contract of Apprenticeship. After completion of the apprenticeship training **no employment shall be given, therefore, no obligation on part of Sasan power limited to offer any employment thereafter.**
4. **Mode of Selection:** For the purpose of short-listing quality candidates, the screening process have three steps:
- i. **Academic excellence:** Aggregate marks in B.Tech /B.E. / Diploma/ ITI/ 12th and 10th. The list of shortlisted candidates for written examination will be intimated to respective Institutes heads.
 - ii. **Written examination:** Short listing for written examination ratio 1: 6. The written exam will be on general knowledge & aptitude.
 - iii. **Personal Interview** by the selection committee : candidates qualifying the written examination will called for personal interview ratio 1:3
- e. Final merit list will be prepared based on total marks obtained as defined in the above selection process. The shorted-listed candidates shall be called for document verification followed by medical examination as per Mines Rule. The candidates would be required to furnish documents regarding proof of Date of Birth, Qualification, etc
 - f. Based on the requirement of the company, the final shortlisted candidates will be communicated after due approval of management.
 - g. Candidates should register themselves for apprenticeship in Government of India portal (www.aprrnticeship.gov.in or <http://portal.mhrdnats.gov.in>) and select for Sasan Power Limited, for undergoing training with Sasan Power Limited. This is compulsory. The unique

number generated on this website must be produced at the time of reporting otherwise the application will not be accepted.

- h. No TA / DA will be paid to the applicants called for any stage of engagement process
5. **The candidates at the time of reporting should submit an affidavit on non-judicial stamp paper sworn-in before a Magistrate or Notary Public to the effect that they have neither undergone apprenticeship/ practical training from anywhere earlier nor have taken employment anywhere.**
6. **Termination of Contract:** After completion of such apprenticeship training for stipulated period, the Apprenticeship Contract shall automatically cease. Any act of indiscipline on the part of the apprentices during the apprenticeship is subject to cancellation of the training.
7. Suppression of facts will lead to disqualification, if found at any stage of the selection process or during the Apprenticeship period.
8. **Accommodation:** Bachelors' accommodation will be provided subject to availability as per rule of the Company. Fooding facility will be available at site on payment basis.
9. **Medical facility:** For self only at the first aid center available at Mines.
10. **Leave:** An apprentice shall be entitled as following for leaves:
- a. Casual Leave of 12 days per year on pro-rata basis and at the discretion of the Appropriate Authority may be admissible to an apprentice.
 - b. Medical Leave of 12 days (full days) per year.
11. **Apprenticeship Hours:** As per the allocated shift hours.
12. **Stipend** – Stipend is as per apprenticeship Act
