- 5) Online submission of form shall not be considered . Tender has to be submitted through India Post Registered Post or Speed Post Only. No other means will be entertained.
- 6) Tender has to be submitted through sealed envelope with their sign on envelope.
- 7) All documents have to be attached.
- 8) Tenderer shall not be considered or entertain the work to more.
- 9) Rate should be quoted including GST & all taxes .Any rates/taxes other than quoted shall not be considered.
- 10) Octorai exemption certificate will be issued by the consignee, if is not accepted by the local authorities the tenderer will have to pay the charges.
